Position Purpose

To carry out the installation, overhaul and minor fabrication of equipment associated with wayside mechanical signalling systems.

Position Responsibilities

1. Install and overhaul mechanical signalling equipment including pneumatic and/or hydraulic systems in accordance with relevant technical standards, practices and procedures.
2. Perform fabrication and welding work associated with wayside signalling systems and equipment.
3. Install diesel engines associated with stand by power supply systems utilised by Network.
4. Maintain records with regard to installation and testing activities.
5. Ensure all work practices comply with the Workplace Health and Safety (WH&S) Act and Queensland Rail's safety policies and procedures.
6. Progress the implementation and application of Quality principles and practices in pursuit of assuring and continuously improving quality.
7. Liaise with staff in other sections to effectively carry out the duties of the position.
8. Assist in the installation of Network equipment that requires competencies above this position.

Additional Factors

The appointee will be required to :-

- Comply with Queensland Rail's Code of Conduct;
- Observe all legal and safety obligations of the organisation;
- Be available for call out/stand by duties, overtime and higher grade relief as required;
