- Lead a multidisciplinary team of project professionals to provide expert services in cost management and control, project risk; scheduling and project governance and reporting and provide projects administrative and coordination services across SEQ Project Delivery in all phases including construction and contract management.
- 2. Foster strong relationships and collaborate with the EPMO and

key stakeholders in the delivery of projects and major works to ensure projects comply with the organisational project management, contract management and legislative frameworks and governance for infrastructure assets.

- Provide leadership and direction to managers, support staff and delivery partners across Project Delivery, identifying opportunities for cross-initiative coordination and integration of support to ensure consistency across teams.
- 4. Review, build and maintain processes to ensure project data, documentation, report and submissions are relevant, accurate and developed to the best standards.
- 5. Establish and maintain a continuous improvement process in project delivery by evaluating project performance and lessons learned including resources and skills analysis and benchmark against similar industries across all phases of the project lifecycle including construction.
- Act as point of escalation and/or mediation where risks arise with the potential to adversely impact a greater program and portfolio of work including accountability for direct intervention.
