## Position Purpose

Provide specialist safety and risk advice and support to the Queensland Train Manufacturing Program (QTMP) team in the development of safety and risk process, procedures and management plans associated with the delivery of the QTMP.

## Position Responsibilities

1. Support the design, implementation, evaluation and continuous improvement of safety and risk management frameworks and plans, inclusive of methodologies, systems, processes and procedures.
2. Develop Queensland Rail project safety documentation and support the implementation of project safety requirements across QTMP.
3. Lead the development and implementation of Queensland Rail safety assurance plans.
4. Conduct audits, observations, inspections, documentation reviews and incident investigations, in accordance with approved assurance processes, to ensure compliance with safety, environmental and risk management requirements and provide reports and recommendations for continual improvement.
5. Support the development and implementation of Queensland Rail integrated risk registers and risk management plans and facilitate risk assessments.
6. Work with Corporate Safety team to ensure safety processes and procedures utilised are in alignment with Queensland Rail's standards, policies and procedures.
7. Ensure safety risks are identified and addressed and compliance with safety legislation and Queensland Rail's Safety and Environment Management System is managed.
8. Drive the implementation of safety strategies and systems to improve the safety performance and reporting within QTMP.

## **What is the key selection criteria**

3. High level of communication and interpersonal skills to engage effectively with management and staff and deliver quality safety outcomes.
4. Substantial knowledge of enterprise wide risk management processes, assurance principles and compliance methodologies, relating to Work Health and Safety, Rail Safety and Environment legislation and related ISO and AS/NZS standards.
5. Substantial level of analytical, problem solving, interpersonal and communication skills including the ability to think and work strategically.
6. Substantial level of skills in investigations and report writing, particularly related to safety, accidents and unsafe work practices.
7. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
