Position Purpose

Take a lead role in the implementation of the Configuration Change & the development of Systems Engineering & System Safety strategy for Queensland Rail Major Projects, which defines the mandatory requirements and criteria for progressive assurance and acceptance of the new/modified assets into the operational railway. Interface closely with internal and external stakeholders to ensure delivery is in accordance with contract Railway Transport Operator (RTO) requirements and work with the Discipline Head of Systems Engineering to embed Systems.

Position Responsibilities

1. Proactively identify areas of Systems Engineering deficiency to effect continuous improvement and monitor all non-conformances identified in system integration and assurance activities to close out, ensuring control effectiveness.
2. Provide Systems Engineering management, guidance and advice to project leads and multi-disciplinary team in the development of assurance processes and artefacts.
3. Engage internal and external stakeholders to ensure Systems Engineering and integration activities are undertaken in accordance with the asset acceptance strategy and provide input into the development of associated asset acceptance plans.
4. Lead (and develop where required) coordination of Systems Engineering and technical assurance artefacts in support of the asset acceptance strategy.
5. Lead and undertake system engineering assurance activities in accordance with approved processes to ensure compliance and efficacy. Enable effective and appropriate levels of status reporting to key audiences on a weekly basis of assurance delivery.
6. Mature railway integrity and assurance plans (RIAP) and Railway Integrity Assurance Reports (RIARs) progressively in accordance with

MPI delivery schedule. Taking a Systems approach, align Configuration Change assurance activities with delivery approach.

7. Ensure quality of artefacts for presentation to the Railway Change Authority and Configuration Change Panel for approval.

4. High level of skill in managing a large range of diverse stakeholders with specific interests including, senior leaders, employees, regulatory agencies and internal / external subject matter experts and the ability to work well within a multi-disciplinary team.
5. High level of influencing, interpersonal, consultation, relationship building and negotiation skills that build and sustain productive relationships and partnerships.
6. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
