7. Provide accurate, timely and up to date information in hard copy to the Administration and Management team to ensure accurate budget monitoring and accurate cost capture can be achieved.(time confirmation, work orders, delivery dockets, tax invoices, etc).

- Observe all legal and safety obligations of the organisation;
- Work outdoors;
- Attend further training as required.
