Position Purpose

Provide professional Civil engineering services in relation to SEQ Civil Structures. To support and advise on civil and structural engineering issues to improve the reliability of the SEQ Rail Network ensuring structures assets are inspected, repaired and renewed when required to appropriate engineering standards.

Position Responsibilities

- 1. Provide professional structural engineering support to the Structures Engineering Coordinator SEQ and Structures and Civil Team.
- Monitor, review and support the compliance of the management of SEQ structures and inspections according to appropriate standards.
- 3. Support the development, implementation, maintenance and review of the long term asset management plans for the structures assets.
- 4. Develop and implement predictive asset condition modelling tools and procedures with the below rail planning team to improve the reliability and life cycle cost of civil structures assets.
- 5. Conduct engineering and technical investigations and prepare reports associated with asset safety, condition and reliability issues.
- 6. Provide professional civil engineering advice and construction supervision for asset renewal and asset reliability projects.
- 7. Liaise with expert technical engineering personnel from internal divisions or external consultants as required.
- 8. Participate in the civil engineering inspections in the SEQ network as required by the Civil Engineering Track and Structures Standards (CETS and CESS).
- Ensure technical, asset, engineering and project records are maintained up to date, accurate and in an accessible form for projects managed by this position.
- 10. Relieve in the Structures Engineering Coordinator position as





required.

 Preparation of briefs for associated engineering and/or structures work to be released for tender to consultants and contractors. Management of consultants and contractors engaged to achieve required outcomes.
