Position Responsibilities

1. Participate as a member of the CRR Possessions Integration leadership team to provide expert advice on key corridor access issues for the CRR Program and associated projects.
2. Lead and effectively coordinate all possession planning, scheduling and management through effective analysis of conflicting project dependencies and milestones and develop options that optimize project delivery, business and operational outcomes.
3. Work within business-wide and project management governance, client and legislative requirements and ensure all CRR Program corridor access activities are conducted in accordance with the applicable SEQ Network practices, policies, standards and procedures.
4. Build and manage constructive and collaborative relationships with key external and internal stakeholders including the interface between CRR Program Delivery team and Queensland Rail Corridor Access Management team to balance access demands across train operations, infrastructure maintenance, capital projects and the CRR Program of work.
5. Act as a point of escalation or mediation where risks arise with potential to impact business and or program objectives, including accountability for direct intervention.
6. Contribute to a high-performance culture focused on safety leadership, team work, stakeholder engagement, collaboration and achieving high-quality delivery and performance outcomes whilst
