## **Position Purpose**

To maximise productivity for Queensland Rail through efficient and cost effective management of the updating of Queensland Rail Route Maps and GIS information into a format which is utilised by field employees in a timely and accurate manner, and maintain Queensland Rail GIS datasets, processes and procedures to recognised best practice.

## **Position Responsibilities**

1. Act as custodian of rail and bus route maps responsible for optimisation of information, preparation, management and distribution of train and bus route maps.
2. Perform GIS tasks to support the business needs of the organisation, ensuring data and system integrity, including the production and maintenance of data to enable spatial recognition for Asset Lifecycle Management.
3. Maintain spatial databases to Database Management Systems (DBMS) standards.
4. Investigate and action data change notifications from internal stakeholders.
5. Perform general GIS and related administrative duties.
6. Assist the Digital Engineering Manager in the development, implementation, integration and ongoing governance of geo-spatial systems and their respective design philosophies within an integrated framework.
7. Apply a multi-disciplinary approach to the management of spatial asset data utilising effective stakeholder engagement techniques where required.
8. Actively participate in an environment that encourages employee involvement towards a GIS business improvement culture.

5. Substantial level of Asset Lifecycle Management philosophies and practices within a GIS environment including data relationships and system architecture.
6. Substantial level of conceptual, analytical and problem solving skills, including solutions analysis.
7. Substantial level of planning and organizational skills, along with a high degree of detail orientation.
8. Substantial level of interpersonal communication, consultation and negotiation skills that builds and sustains productive relationships and partnerships with both internal and external stakeholders.
9. Substantial level of skill as a team member who thrives in environments requiring ability to effectively prioritise and manage multiple concurrent tasks.
10. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviors.
