## **Position Purpose**

Act as a proactive partner between the Integrated Operations Planning (IOP) Portfolio Operational Readiness team and Queensland Rail Business Units to build capability and support the successful execution of readiness activities, standardised processes and tools, share specialist information, and promote cross-functional collaboration to ensure Queensland Rail is able to successfully operationalise and sustain its Capital and Operational project portfolio.

## **Position Responsibilities**

- 1. Partner with the business to implement and embed the Operational Readiness framework, timetable readiness checklist, tools and processes to the portfolio of projects.
- Proactively seek opportunities to improve associated material to meet the requirements of detailed portfolio assessments, readiness reporting and strategic, evidence-based and data driven decision making and the framework end-users.
- 3. Identify and actively monitor Operational Readiness activities at the project & program level to provide an aggregated view of portfolio level impacts, risks and issues.
- 4. Act as a conduit between IOP, Portfolio Operational Readiness team and the business to ensure ongoing communication and tracking of readiness criteria and milestones.
- Identify, assess and communicate cross-functional impacts to Queensland Rail Business units through the analysis and interpretation of portfolio readiness data to inform insights, operational impacts, dependencies, risks, issues and opportunities.
- 6. Support the development and maintenance of integrated portfolio reporting to identify operational risks, issues and opportunities and provide supporting recommendations.
- 7. Establish and maintain effective relationships with business and



projects community stakeholders, senior leaders to ensure the effective communication and execution of Operational Readiness planning requirements, delivery of the portfolio and alignment to Queensland Rail's Strategic and Corporate objectives.

8. Perform regular Operational Readiness health checks on Projects and portfolio and escalate issues to Manager when identified.
