To assist Project Delivery Services and Project Managers across Queensland Rail by providing analytical and business related project finance services, both through the implementation and management of various financial and non-financial systems; and the preparation of a wide range of specialist costing reports.

#### **Position Responsibilities**

- Develop and manage procedures that satisfy financial and audit reporting requirements for Project Managers, internal and external clients and other government organisations.
- 2. Manage project accounting procedures in order to ensure:-
  - Transparency of total project revenue and costs;
  - Revenue and costs are forecast, captured and reported on a timely basis.
- 3. Develop and manage a wide range of business relationships with project managers, work providers, internal and external clients and various government agencies to help Queensland Rail reduce the risks of not meeting client needs and so that business improvements can be implemented more easily within Queensland Rail.
- 4. Develop and manage cashflow reporting for projects showing:-
  - Forecast vs actual costs variances highlighting costs that are incorrect or missing;
  - Revenue vs actual cost variances highlighting funding deficiencies and outstanding progress claims.
- Identify risks that will impact on project cost reporting accuracy and timelines due to business processes and procedures and perform business process audits providing recommendations for business changes / improvements.

cashflow and costing estimates for use by Project Managers, Queensland Rail Senior Management, external developers and government agencies.

- 7. Provide expert advice and assistance to project managers and officers on SAP related issues to help ensure only correct costs settle to projects.
- 8. Provide guidance / support to Project Officers on financial management of projects in SAP.
