- Support Team Leader Contracts in financial management, including monthly budget analysis, forecasting, billing, recovery, and purchase order creation.
- 5. Submit applications and negotiate approvals with internal Queensland Rail Business Groups and suppliers for the installation and upgrade of advertising and vending assets, ensuring compliance with Queensland Rail policies, standards, and requirements.
