Position Responsibilities

- 1. Be the lead agent for the interface between the Rail Safety and Accreditation team and operational and project teams for operational rail safety risk management issues.
- 2. Provide expert advice to frontline, senior and executive management in relation to operational rail safety risk.
- 3. Facilitate initial interrogation of identified risk and change management activities.
- 4. Manage the interface and involvement of subject matter experts in operational rail safety, safeworking and rail safety legislation and accreditation, to deliver expert advice and practicable and effective risk management outcomes.
- 5. Lead improvement initiatives and activities in regard to rail safety risk and ensure all activities align with the Queensland Rail Safety Strategy program of work.
- 6. Develop and maintain operational safety intelligence tools for the interpretation of reliability and safety data including rail safety quantity and risk metrics.
- 7. Participate in relevant internal forums and meetings to contribute to, and influence controls that will mitigate operational safety incidents, and ensure appropriate information flow to the Manager

- 8. Conduct relevant research and benchmarking in order to ensure Queensland Rail's performance and strategy is aligned to risk and contemporary safety management practices.
- Maintain oversight of, and actively influence risk registers and related controls in terms of their effectiveness in operational rail safety risk management.
- 10.Participate in and review reports arising from Rail Safety incident investigations and undertake the appropriate coding of contributing factors.
