#### **Position Purpose**

The position is responsible for managing the authorisation of third party entry onto Queensland Rail property, coordination of contractor corridor access requests and the development and prioritisation of work schedules that deliver safe, efficient and effective operations for Major Projects Integration's program of works from a strategic viewpoint.

#### **Position Responsibilities**

- Lead and coordinate all non-SCAS corridor requests from contractors to facilitate the delivery of complex project programs, ensuring these are resourced accordingly by critical Queensland Rail disciplines.
- 2. Develop and manage detailed risk management plans that fulfil safety and operational requirements for Major Project Integration's program of work in consultation with stakeholders.
- 3. Develop and manage a framework to coordinate site access requests, ensuring continuous improvement of established processes, identifying emerging risks, integrating evolving operational and safety requirements, and compliance with relevant defined planning protocols.
- 4. Coordinate and manage stakeholder planning meetings to review corridor access requests and resource requirements for planned SCAS and Non-SCAS Possessions, ensuring effective use of assets, compliance with safety and operational protocols, and appropriate authorisations.
- 5. Provide detailed performance reporting and advice regarding issue management, optimisation of resources and fulfilment of planned works to support high level stakeholder briefings and correspondence, including the use of ViziRail for extracting detailed analyses.

- Maintain current knowledge of relevant property and rail safety legislation, policies, Queensland Network Rules and Procedures and trackside safety standards to ensure legal compliance and risk management.
- 7. Liaise with and support the Integrated Possessions Coordinator and Integrated Possessions Lead to identify and resolve activity conflicts and ensure delivery of an optimised possession program.

- 5. High level of skill in scheduling, programming and monitoring integrated possessions and management of adhoc possession requests to achieve program milestones and stakeholder expectations.
- High level of communication, interpersonal and negotiation skills to maintain effective stakeholder networks and deliver solution-based outcomes.
- 7. High level of skill in responding to complex operational issues with innovative and effective solutions.
- 8. High level of skill in the application and interpretation of legislation, policies, practices and issues relevant to the negotiation and formalisation of Agreements for the use of Queensland Rail property and assets by third parties.
