Position Purpose

Manage and provide strategic leadership and accountability for the successful acceptance of new assets as the Rail Infrastructure Manager (RIM) on behalf of Queensland Rail, serving as the external interface for integration of major rail infrastructure programs within the Major Projects, Engineering and Rail Safety (MPERS) team. Ensure the external readiness for integration is delivered consistently with industry best practices and standards, meeting the requirements of relevant Delivery Authorities, DTMR, and other key stakeholders focusing particularly on program integration readiness for Queensland Rail, especially in SEQ as the responsible business.

This role will provide advice to the Queensland Rail Executive team, CEO, and Board, and operate within Alliance and PPP environments alongside Delivery Authorities. It is accountable for managing a complex range of external stakeholder objectives and relationships, including government agencies and internal interfaces with the SEQ Integration team, to enable successful integration and acceptance of new assets as RIM on behalf of Queensland Rail across current and future major programs.

Position Responsibilities

- 1. Participate as a member of the MPERS leadership team and partner with the Program Director Delivery, Major Projects to provide senior leadership of key issues relating to the integration of the CRR and ETCS projects, the LGC Rail, B2N and DSC line projects and other major programs assigned to the MPERS team in a dynamic and changing rail network and passenger transport environment.
- 2. Lead and provide clear, timely advice, direction and development, to external stakeholders, of Queensland Rails integration program.
- 3. Drive and manage the acceptance of new assets as RIM for Queensland Rail to enable successful integration of major rail programs,

emphasising strategic, efficient, and effective use of resources. This includes working closely with Queensland Rail divisions, particularly through interface with GM SEQ Integration, to ensure operator readiness - infrastructure, people, and supporting PMO initiatives such as the DTMR Rail Network Strategy.

- 4. Lead interfaces with external stakeholders on integration of program requirements, including engineering, commercial, constructability, and human factors, fostering strong interdisciplinary engagement and accountability aligned with project management disciplines, schedules, and reporting.
- 5. Provide integrated management to the external program teams as a single point of accountability, devolving specific aspects of project and operational decision making to the most efficient and effective levels, to effect the successful acceptance of new assets as RIM on behalf of Queensland Rail.
- Anticipate and manage safety, legal, environmental, and operational risks associated with integrating large infrastructure programs, providing detailed progress and risk reports to executive and boardlevel stakeholders.
- 7. Build and maintain collaborative and constructive relationships with key stakeholders and strategically influence RIM transition decisionmaking ensuring beneficial outcomes for Queensland Rail, CRR, ETCS, LGC, B2N, DSC and other program teams to facilitate a positive end-to-end customer experience as well as improving and optimising the delivery of the projects.
