- 4. High level of skill in driving change and innovation within station design and construction to support the delivery of modern, passengercentric rail infrastructure.
- 5. High level of skill in stakeholder engagement, consultation, and negotiation to influence decision-making and maintain strong relationships with internal and external stakeholders involved in station delivery, including passenger experience and accessibility groups.
- 6. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
