# **Position Responsibilities**

- 1. Assist in the development of and lead implementation of the mandatory requirements and criteria for progressive assurance and acceptance of the new/modified assets into the operational railway.
- 2. Provide input to the development of the Railway Configuration Change integrity and assurance plans and progressively coordinate project package evidence submission, ensuring quality of artefacts for presentation to the Railway Change Authority, working closely with the allocated Railway Integrity and Assurance Manager (RIAM) to ensure approval and gate progression.
- 3. Work collaboratively with internal and external stakeholders to ensure integration activities are undertaken in accordance with the asset assurance plan and the appropriate Queensland Rail policies, standards and specifications. Providing strategic guidance, interpretation of requirements and standards, and advise on key risks, project changes, regulatory compliance, and stakeholder expectations, to project leads and the project team in the development of system definition, contract and assurance artefacts.
- 4. Guide and review systems assurance deliverables produced by suppliers and interfacing parties to ensure they meet obligations. Lead and undertake system and safety assurance activities in accordance with approved processes to ensure compliance and efficacy. Co-ordinating

- and developing where required, technical assurance artefacts in support of the asset assurance plan.
- Proactively identify areas of deficiency to effect continuous improvement and monitor all non-conformances identified in system integration and assurance activities to closure, ensuring control effectiveness.
- Establish and maintain knowledge of critical aspects within contract packages as they relate to asset assurance, acceptance and overall system integration.
- 7. Where asset or operational risks are identified in project evolution, support definition of the requirements for amendments to existing.
