Provide a service to ensure safe, efficient and effective preventative maintenance and repairs of the Travel & Tourism Rollingstock fleet and other rollingstock as required.

Position Responsibilities

1. Contribute to reliability and availability through performance of preventative maintenance and repairs to Traveltrain rollingstock (predominantly Kuranda Scenic Railway trains) in accordance with relevant procedure and instructions.
2. Contribute towards the Kuranda Scenic Railway Carriage Overhaul and Refurbishment Programs in accordance with relevant procedures and instructions.
3. Assist in derailment and accident situations in order to minimise effect on customers and on an as required basis attend to rollingstock other than the Kuranda Scenic Railway trains which may need attention in service.
4. Minimise the effects of in-service rollingstock defects by efficient and timely attendance and repair of the Kuranda Scenic Railway Trains in the field as required.
5. Carry out all work observing safety requirements for yourself and for any others nearby or under your direction or using the equipment being worked on.
6. Carry out all non-skilled depot duties e.g. housekeeping duties (cleaning etc) necessary to ensure the facility is kept clean and tidy and provides a safe workplace.
7. Perform all other duties and functions necessary for the efficient operation of the depot including waste water treatment plant operations.
