Position Responsibilities

1. Provide a high quality of presentation and cleaning of the Rockhampton Tilt Train and other passenger trains as required.
2. Contribute to reliability and availability of the Rockhampton Tilt Train through performance of minor maintenance in accordance with the relevant procedures and instructions.
3. Ensure accurate data input to the Maintenance Management Systems encompassing the SAP and other systems (including component tracing) and maintenance scheduling.
4. Carry out all work observing all relevant safety and environmental requirements.
5. Perform all other associated duties and functions necessary for the efficient operation of the depot.
6. Work in a co-operative relationship with all other employees while carrying out the duties of a Tilt Train Presentation Attendant.

Additional Factors

The appointee will be required to :-
- Comply with Queensland Rail's Code of Conduct;
- Observe all legal and safety obligations of the organisation;
- Work shift work;
- Work a 10 in 14 roster;
- Travel in the area covered by the Depot as required.
