Position Purpose

Position Responsibilities

6. Carry out all work in accordance with the requirements of Queensland Rail's Safety Environmental Management System (SEMS) and business Instructions to control and minimise loss to people, property, processes and environment within their section of Queensland Rail.

- Work away from home station for extended periods;
- Be on call as required;
- Attend further training as required.
