Position Purpose

Lead the successful implementation and operation of the Queensland Train Manufacturing Program (QTMP) contract by providing leadership, expertise and guidance to the QTMP Team to ensure compliance with Queensland Rail's regulatory and contractual obligations.

Position Responsibilities

- Lead, develop and manage the testing and deployment operations focused on planning and maintaining safe integration of the QTMP fleet into Queensland Rail services and on Queensland Rail sites, while meeting regulatory, TSC contract, deed and supporting interface plan requirements to ensure optimal performance outcomes.
- 2. Develop and maintain effective working relationships with Senior Leadership and other relevant internal stakeholders to ensure operational interfaces are managed smoothly for the safe, efficient and effective operation of the QTMP fleet.
- Develop, manage and maintain effective strategic relationships with key external stakeholders including TMR, and other government agencies as required, as well as external stakeholders to manage expectations and meet contractual requirements.
- 4. Lead, develop and manage a diverse program of works to drive performance in line with KPIs and to enable the successful operation of QTMP.
- 5. Review and provide subject matter expertise on documentation (i.e. updates to processes, legal documents, interface plans and deeds, etc) to ensure the safe operation and integration of the QTMP fleet and represent QTMP as required on internal and external committees, working groups and at relevant key stakeholder meetings.
- Work with the QTMP leadership team and other key stakeholders to establish, implement and continuously improve frameworks, programs,

plans and supporting documents for the efficient and effective management of the QTMP fleet.
