## Position Purpose

Provide a service to ensure safe, efficient and effective preventative maintenance and repairs of the Travel & Tourism Rollingstock fleet and other rollingstock as required.

## Position Responsibilities

1. Undertake and deliver projects and modifications to 1720 Locomotives in accordance with relevant drawings, specifications, procedures and instructions.
2. Commission, test, fault find and rectify modification installations including all required documentation.
3. Contribute towards the 1720 Locomotive Project refurbishment programs, if and as required, in accordance with relevant procedures and instructions.
4. Contribute to reliability and availability through performance of preventative maintenance and repairs to primarily locomotive rollingstock in accordance with relevant procedures and instructions.
5. Provide input to improvement initiatives to improve project cost, quality and schedule.
6. Co-operate with other section members to assist in the effective scheduling and completion of work requirements.
7. Assist in component dispatch, goods receipting, cataloguing and just in time delivery of component to work site.
8. Carry out all non-skilled depot duties e.g. housekeeping duties (cleaning etc) necessary to ensure the facility is kept clean and tidy to provide a safe workplace.
9. Ensure accurate data recording for inputting into Enterprise Asset Management System.
10. Undertake all duties in a safe manner in accordance with the

11. Participate in team meetings.

## **Additional Factors**

The appointee will be required to :-

5. Substantial knowledge of electrical work in accordance with the Electricity Act and AS/NZS 3000 Wiring Rules.
6. Sound knowledge of Quality Management principles.
7. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
