Position Purpose

Provide safe, efficient and reliable preventative maintenance, presentation and repair of Traveltrain rollingstock and associated components and equipment to the standards set by the Manager Traveltrain Rollingstock Maintenance.

Position Responsibilities

1. Contribute to safety, reliability and availability of Traveltrain rollingstock by performance of preventative maintenance, fault finding and repairs on rollingstock and equipment in an efficient manner.
2. Utilise computer based maintenance systems to accurately and timely input and review data, such as recording the work performed including repair and preventative maintenance, and all materials used.
3. Work as part of a team with other Maintainers and Traveltrain Presentation Attendants to accomplish the maintenance and presentation objectives as efficiently as possible.
4. Represent Traveltrain Rollingstock Maintenance while liaising with On-Board staff, Rollingstock Defect Co-ordinators, Drivers and Contractors regarding safety, reliability and maintenance scheduling of the rollingstock and attending failures in traffic if required.
5. Undertake all duties in a safe manner in accordance with Queensland Rails Safety Management System (work safely and ensure work environment is safe) and Environmental Management System and all other Queensland Rail policies as issued.
6. Take responsibility for the safe and reliable condition of the traveltrain rollingstock on departure from Mayne Depot.
7. Undertake all non-skilled depot duties (eg. housekeeping, cleaning etc) necessary to ensure the facility, tools, parts and test equipment are kept clean and tidy and provide a safe workplace.

8. Maintain and use all electrical competencies relevant to the traveltrain rollingstock.

Additional Factors

The appointee will be required to :-

- Comply with Queensland Rail's Code of Conduct;
- Observe all legal and safety obligations of the organisation;
- Work shift work;
- Work a rostering methodology developed within the Enterprise Agreement/Award guidelines to best serve the business needs (5 in 7, 10 in 14, extended shifts etc);
- Work in a team environment;
- Travel in the area covered by the runnings of the traveltrain rollingstock as required;
- Work in conjunction with Contractor's staff during the traveltrain rollingstock warranty period;
- Be prepared to provide relief for Electrical Maintainers in Gracemere Depot as required;
- Attend call outs/ins after hours;
- Attend training and re-skilling at a location other than their home depot.

What is the key selection criteria

1. High level of skill in inspection, fault finding and repair of passenger rollingstock, associated systems and their components.
2. Sound PC and Mainframe computer application skills particularly in maintenance management application.
3. Sound level of interpersonal, oral and written communication skills.
4. Sound skills in working autonomously and within a team environment.
5. Sound knowledge of Quality Improvement factors and the Workplace Health and Safety and Environmental Acts.
6. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
