## **Position Responsibilities**

1. Ensure the repair, fault detection and maintenance of City Network Rollingstock and associated equipment, is carried out in accordance with current relevant procedures and instructions.
2. Employees shall be required to perform all electrical work in accordance with the Electrical Safety Act, Queensland Rail procedures and instructions.
3. Carry out electronic, computer and Programmed Logic Controller (PLC) related repairs in accordance with relevant industry standards, Queensland Rail maintenance procedures, instructions and within current competencies.
4. Perform work in accordance with the Electrical Safety Act, Workplace Health and Safety (WH&S) Act and other relevant Legislation, Queensland Rail Safety Management System, Business Instructions and to comply with the Environmental Management Plan for the work location.
5. Develop a customer driven quality focus, team approach, to each task assigned by the Supervisor or Manager.
6. Work in a semi autonomous environment to maintain electric passenger rollingstock in a safe, reliable working condition, which may include investigations into faults, compilation of reports and to assist in the development or review of procedures and processes.
7. Utilise computerised Maintenance Management Systems to input and retrieve data in an effective and efficient manner to maintain the systems integrity.

8. Perform other duties and functions as directed by Supervisors and Management.

3. High level of skills in the interpretation of technical instructions electrical/electronic schematics and the use of specialised electrical/electronic test equipment applicable to electric passenger rollingstock.
4. Substantial level of skill inputting, reviewing and retrieving maintenance data using a computer base system.
5. Substantial level of skill in report writing, investigation process and problem solving, combined with interpersonal and oral communication techniques.
6. Sound knowledge of quality, environmental and safety as applicable to relevant Acts, Standards and Policy.
7. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
