- 5. Identify, assess and report on risks and opportunities pertinent to Telecoms in relation to the MPI and capital works Program and vice versa communicate findings to the project teams and make recommendations where possible to mitigate risks.
- 6. Monitor and report on Business Readiness requirements and milestones pertinent to Telecoms in relation to the MPI and capital works Program.
- 7. Provide regular reports on the progress of testing and deployment, that identifies risks, barriers and mitigation.
- Accountability for the planning and delivery of Queensland Rail works, including works delivered by internal Queensland Rail teams



and suppliers directly engage by Queensland Rail.
