5. Monitor, record and report on project performance by comparing actuals against planned criteria.
6. Produce regular reports, advice and feedback to Project Services Management, Queensland Rail Senior Management and clients on the requirements to meet Queensland Rail's works portfolio.
7. Generate performance indicators on the effectiveness of the project management processes in meeting the planned commitments.
