Position Purpose

Position Responsibilities

4. Maintain records and associated documentation relating to asset condition, maintenance programs and costing systems.
5. Report on actual work performed against the scheduled maintenance program and equipment performance and condition irregularities.
6. Progress the implementation and application of work procedures and practices in pursuit of assuring and continuously improving quality.

Additional Factors

The appointee will be required to :-

- Comply with Queensland Rail's Code of Conduct;
- Observe all legal and safety obligations of the organisation;
- Be available for call out/stand by duties, overtime and higher grade relief as required;
- Work away from home station and travel throughout Queensland as required;
