Position Purpose

To implement and maintain protective security risk management and education strategies for Queensland Rail in order to comply with legislative, assurance and policy requirements and to address the specific needs of Queensland Rail relating to the protection of its staff, information, assets and operations.

Position Responsibilities

1. Produce security risk assessments and protective security reviews for Queensland Rail as part of the Security Risk Program of Work.
2. Assist in the development and implementation of security risk based strategies designed to reduce the frequency and severity of security incidents occurring across the network.
3. Develop and deliver threat based security and counter terrorism education packages to Queensland Rail employees, aligning to national/international guidelines, and consideration for Australian Skills Quality Authority (ASQA) standards (where national units of competency apply).
4. Provide specialist protective security advice to Queensland Rail employees on any operational security issue.
5. Provide detailed protective security advice to new and existing development or upgrade projects to ensure protective security considerations are included at the commencement of projects.
6. Liaise and negotiate with key stakeholders in regards to security risk management issues and the implementation of security initiatives.
7. Assist, as required, in matters directly related to Queensland Rail's security program.

Additional Factors

The appointee will be required to :-

- Comply with Queensland Rail's Code of Conduct;

4. High level of interpersonal skills including the ability to conduct presentations in a formal and informal setting.
5. Substantial Knowledge and understanding of relevant security focused legislative requirements for Queensland Rail.
6. Substantial level of skill in the use of Microsoft applications, particularly Excel and Powerpoint.
7. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
