## **Position Purpose**

Lead and manage the Asset Integration and Augmentation of Queensland Train Manufacturing Program (QTMP) assets safely into the Queensland Rail network, whilst also providing leadership and coordination strategies to functions consisting of Testing & Deployment, Training, and Operational Readiness.

## **Position Responsibilities**

1. Participate as a member of the QTMP leadership team to provide leadership and strategy of Operational Readiness, Testing & Deployment and Training & Delivery in a changing integrated passenger and rail infrastructure environment through effective strategy formulation, customer, business partner and stakeholder engagement, and people leadership.
2. Provide highly specialised expert change management advice, support and coaching to the Asset Integration and Augmentation team, Sponsors, Executives and Senior Leaders across the business to ensure a smooth transition to the desired end-state of change that ensures employee adoption and usage.
3. Safely deliver the QTMP assets into the Queensland Rail network within contractual timeframes and within budget, whilst also managing safety and operational risks associated with a large infrastructure program.
4. Provide leadership and support of the QTMP Operational Readiness Training & Resourcing Strategy, in consultation with key stakeholders, and undertake the relevant change management activities to educate and embed best practice training.
5. Develop and maintain effective business relationships with senior internal and external stakeholders and provide an internal consultancy service with regards to business and operational



readiness activities.

6. Provide regular and proactive reporting on the progress of the Asset Integration and Augmentation function of the QTMP program identifying progress, risks, issues, foresight, and mitigations to ensure the ongoing smooth integration of new assets into the Queensland Rail network.
7. Lead the successful implementation and subsequent benefits realisation of the QTMP through the delivery (safety, on time, on budget, on scope) of allocated capital and operational programs.

### **What is the key selection criteria**

1. High level of skill in leading and managing multi-disciplinary teams of technical specialists and project managers to deliver large-scale rail infrastructure and asset integration programs.
2. Extensive knowledge of operational readiness frameworks including testing, commissioning, training, and deployment methodologies within a live rail network environment.
3. High level of skill in change management, including developing and implementing transition strategies and coaching senior leaders to ensure successful adoption of operational changes.
4. High level of skill in engaging, influencing, and negotiating with senior internal and external stakeholders, including government agencies and industry partners, to support program delivery and compliance.
5. Extensive knowledge of rail safety standards, operational risk assessment, and mitigation techniques relevant to network integration of new assets.
6. High level of skill in designing and managing operational readiness training and resourcing strategies aligned with regulatory and business requirements.
7. High level of skill in preparing, reviewing, and presenting complex program documentation, technical reports, and governance materials to executive and stakeholder audiences.
8. Knowledge of and willingness to commit to and work within Queensland Rail's Values and Behaviours.
