Position Purpose

Manage the operation and train movement activities within the Mayne Rail Complex, Electric Stabling Out Depots and Remote Controlled Signalling Stabling Areas to safely and efficiently maximise the utilisation of Rollingstock.

Position Responsibilities

1. Control all train movements and operational aspects safely within the confines of Mayne Rail Complex.
2. Ensure that employees and Contractors entering all SEQ Rail Yards comply with all rules and procedures including the issuing of Safeworking forms.
3. Manage the allocation of electric units to meet the business and operational requirements including Electric Stabling out depots and NGR RCS Stabling Areas to ensure the allocation of Rollingstock to meet on time performance.
4. Maintain a safeworking environment of the Mayne complex in conjunction with other business groups including overseeing accident/incident reporting, monitoring security movements and managing emergencies and act as Chief Warden within the Mayne Rail Complex.
5. Manage the RCS Stabling sites to ensure a safe environment for Queensland Rail employees and contractors is maintained by receiving and rectifying yard issues and overseeing accident/incident reporting.
6. Advise the Train Control Supervisor of the availability of units in a timely manner to enable operational requirements to be met.
7. Manage the use of rail operating systems to ensure the efficient and safe operation of Rollingstock in line with Queensland Rail operational requirements and safe working systems.
